

# Evidence of your Finances for STUDENT ROUTE visa applications



As part of your visa application the UKVI will assess whether you have sufficient funds to study in the UK. Your visa application must demonstrate that you have either money for boarding fees or sufficient course and maintenance funds (for living costs) for the first year of your course, less any deposit paid

If your CAS states	You are studying in London	You are studying outside of London
<b>Boarding fees (example 1)</b>	Course fees + accommodation fees	Course fees + accommodation fees
<b>Course fees (example 2)</b>	Course fees + £1,334 per month of studies (up to 9 months)	Course fees + £1,023 per month of studies (up to 9 months)

### Date of statement

The bank statement must not be dated more than 31 days before the visa application date (which is associated with the payment of the visa application fee).

Your bank statement can be an original or an electronic bank statement. It must feature the bank logo, address, issue date and name of account holder.

### Account name

You can use money held in an account belonging to you or your parent. If using the account held by your parent(s) you must provide evidence (generally a birth certificate) to prove you are related, and a financial consent letter, stating that their funds are available to use for your studies in the UK.

If your funds are not held in British pounds sterling (GBP), please check the OANDA website ([www.oanda.com](http://www.oanda.com)) for exchange rates to ensure you have enough money.

The required level of funds must be held in the account for a minimum of 28 consecutive days (finishing on the date of the closing balance).

### Example 1

You have applied for a 2-year A Level course at CATS College London and have requested college accommodation.

#### Boarding Fees (course + accommodation)

£29,985 + £19,995 = £49,980

#### Fees Paid

£2,500

#### You are required to show

£49,980 - £2,500 = £47,480

### Example 2

You have applied for a 2-year A Level course at CATS College London and staying in independent (not college) accommodation.

#### Course Fees

£29,985

#### Maintenance Funds

£1,334 x 9 months = £12,006

#### Fees Paid

£2,500

#### You are required to show

(£29,985 + £12,006) - £2,500 = £39,491
