

FAQs on Completing the Standard Visitor Visa

Please see below advice some of the questions we are often asked when completing the application for the Standard Visitor Visa

1. Once you have completed the questions on language you will be asked to select your country and to confirm that you are able to provide your biometrics in that country.

You must check the available biometric enrolment locations for your country of application. You will not be able to change your country of application after you have submitted your application.

If you have entered a country where no biometric enrolment location is available, then you will be redirected to another country. If it is difficult for you to travel to the redirected country, then you can [change the country where you will be providing your biometrics](#).

2. Once these pages are completed you will then start your visa application. You will be asked to register a suitable email address and provide your personal details as well as any criminal convictions and travel history. You will also be asked to state the reason for your visit.

3. You will need to state the dates you intend to arrive in and leave the UK. Please note that you must leave the UK within 6 months of your arrival as a Standard Visitor.

Biometrics

Once you have completed and paid for your application you will need to make an appointment to complete your biometrics and upload any further documents.

Please ensure that you take the following information with you:

- Certificate of enrolment issued by CATS Colleges/CSVPA
- Evidence of finances (proof that you can pay your fees and support yourself while in the UK)
- Your passport
- Details of where you will be staying
- Any additional documents requested as part of your visa application.
